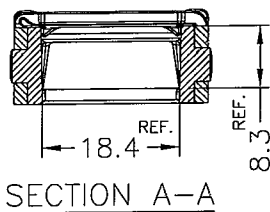
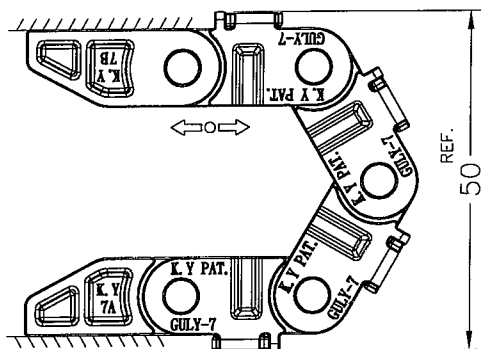
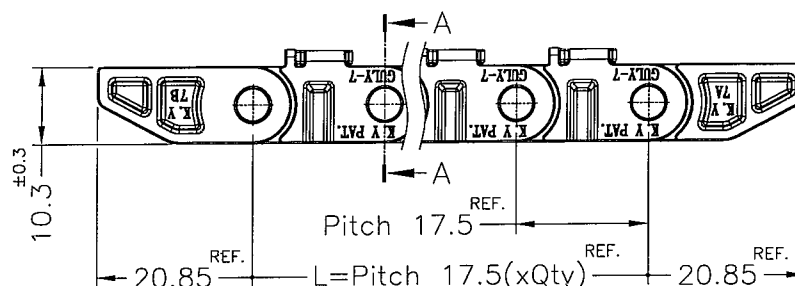
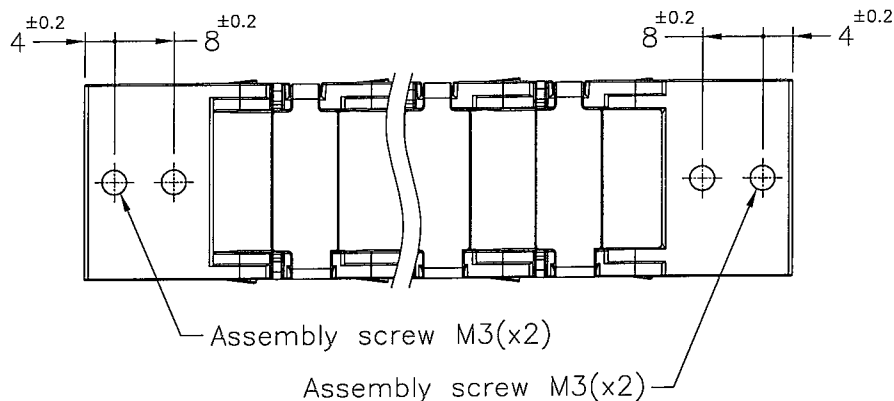
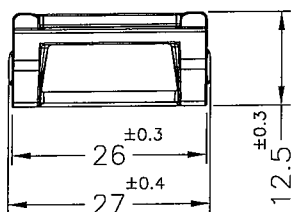


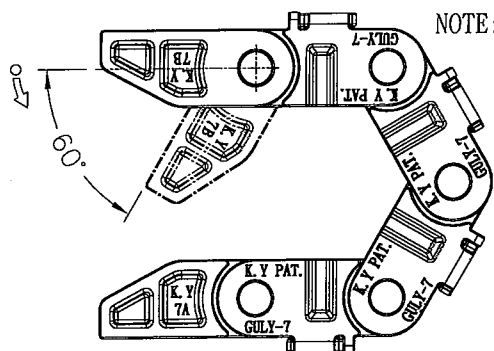
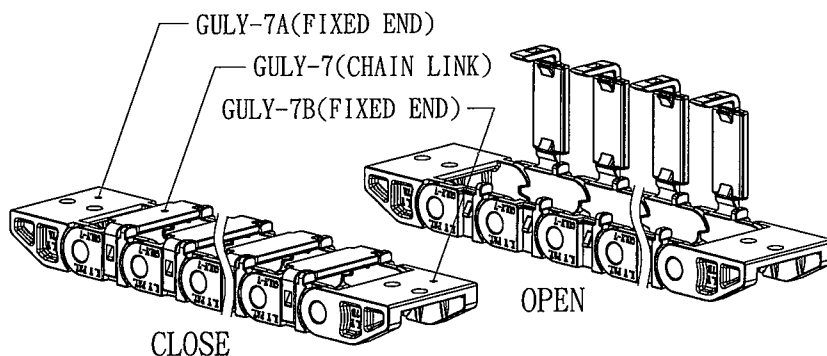

NOTE: 1. GULY-7AB-□F: THE BLANK MEANS QUANTITY, THE P/N WILL BE CHANGED ACCORDING TO REQUEST. FOR EXAMPLE, 20 PCS OF GULY-7 NEEDED, THEN THE P/N WILL BE GULY-7AB-20F.
